Auxiliary Q3 Contribution: In November, we surprised the Board of Directors by doubling the Auxiliary's third quarter contribution to the clinic from \$150,000 to \$300,000! They were extremely grateful for the unexpected increase in funds.

Angel Baby Bags: Three hundred diaper bags and contents for each have been donated by the Auxiliary Chapters for new mothers at the Clinic. Fifty six of those bags were donated by the Auxiliary Junior Board.

Coat Drive: The Auxiliary raised nearly \$13,000 to purchase new coats from the Warming Project. We distributed 1,400 coats to Clinic families.

Janie's Food Pantry: We continue to support the food pantry with volunteers on Mondays from 12pm-2pm restocking the pantry shelves and Tuesdays from 9:30am-3pm checking in patients and helping them shop the pantry. A partnership with Loyola Academy's Arrupe Service Club was created. Students volunteer to help in the food pantry on Wednesdays from 4-6pm. Food deliveries will resume on January 27 from the Chicago Food Depository after a halt in December due to water damage on the first floor of the clinic.
